A. Problem Statement

Under existing law, a person who solicits, or who agrees to engage in, or who engages in, any act of prostitution with the intent to receive compensation, money, or anything of value from another person is guilty of disorderly conduct, a misdemeanor. Also under existing law, if the person solicited was a minor, and the person who solicited the minor knew or reasonably should have known that the person solicited was a minor, the offense is punishable by imprisonment in the county jail for a mandatory minimum of two days and not to exceed one year, by a fine not to exceed \$10,000 or by both such fine and imprisonment.

Chapter 617, Statutes of 2024 (SB 1414) will make this offense applicable only to a defendant who is 18 years of age or older at the time of the offense. The bill will, if the person solicited was under 16 years of age, or if the person solicited was under 18 years of age at the time of the offense and the person solicited was a victim of human trafficking, make the offense punishable as a wobbler by imprisonment in the county jail for not more than one year and a fine not to exceed \$10,000 or by imprisonment in the county jail for 16 months or two or three years. For a second or subsequent offense under those conditions, the bill will require that the offense be punishable as a felony by imprisonment in the county jail for 16 months or two or three years.

The Sex Offender Registration Act requires persons convicted of certain sex crimes to annually register as a sex offender, as specified, for a term of 10, 20, or 30 years.

SB 1414 will require a person who is 18 years of age or older, on or after January 1, 2025, is convicted of, and who has a prior conviction for, soliciting a minor, as specified, to annually register as a sex offender for a term of 10 years if, at the time of the offense, the person was more than 10 years older than the solicited minor. CJIS maintains the California Sex and Arson Registry (CSAR) and will require additional resources to implement the changes to the Sex Offender Registration Act.

1.0 Crime Analyst (CA) I - Permanent, beginning 7/1/2025

The CA I within the Violent Crime Information Center to analyze criminal history and related information to establish a sex offender's requirement to register pursuant to Penal Code (PC) section 290, assess the California registration requirement of sex offenders who have been convicted in California (adult & juvenile), out-of-state, federal, military, or foreign courts, interpret statutory codes and laws for updating criminal record information on sex offenders, and collect and prepare documentation for assessment review by the Deputy Attorney General (DAG) staff assigned to the California Sex Offender Registry.

Bureau of Criminal Information & Analysis (BCIA)

CAI - 95 Overtime Hours in FY 2025-26 and ongoing

CA I overtime is necessary to process the increase in arrest fingerprints from the expansion of the crime of perjury.

C. Departmentwide and Statewide Considerations

With the receipt of funding, CJIS will be able to address the duties associated with the increased workload.

D. Outcomes and Accountability

The additional resources requested under this proposal will enable DOJ to implement SB 1414 with regard to the CSAR, which is the repository for all sex offender registration information in California. With the additional resources, DOJ will be able to assess and designate a tier level in CSAR to the new sex offender registrants from SB 1414.

E. Implementation Plan

Upon approval of this request, the DOJ will begin the hiring process to secure the necessary resources to implement the mandates of SB 1414.
