A. Problem Statement

Beginning January 1, 2025, Senate Bill (SB) 1161 will make changes to statutes that govern sealing of juvenile records to make more juvenile records eligible for sealing. Specifically, the bill will:

- Require the juvenile court, if the person whose case has been certified to a juvenile court
 has their records sealed in juvenile court, to order all criminal court records associated with
 that juvenile record sealed.
- Authorize a person to petition for record sealing if their felony or misdemeanor involving moral turpitude has been dismissed, vacated, pardoned, or reduced to misdemeanors that do not involve moral turpitude.
- Authorize a person who has been cited or arrested for a felony while a minor to petition the
 court for an order sealing record in the case if the person was released from custody
 because there are insufficient grounds for making a criminal complaint against the person,
 proceedings against the person were dismissed, or the person was discharged, without a
 conviction, or the person was acquitted.
- Require a probation department, the DOJ, and the law enforcement agencies to seal the
 citation, arrest, and other records in their custody relating to a juvenile's arrest and
 detention if the prosecutor has declined to initiate proceedings within the applicable
 statute of limitations.
- Modify the definition of juvenile case files to include any writing as defined in Section 250 of the Evidence Code or electronically stored information relating to the minor that is filed in that case or made available to the probation officer.

Existing law subjects a minor between 12 and 17 years of age, inclusive, who violates any federal, state, or local law or ordinance, and a minor under 12 years of age who is alleged to have committed specified serious offenses, to the jurisdiction of the juvenile court.

B. Justification

The California Justice Information Services (CJIS) Division will require a permanent position and temporary help hours in 2025-26 to implement the IT system changes resulting from SB 1161.

The Java/SQL Developer will conduct development and component modification, quality assurance and project management.

Information Technology Specialist (ITS) I – 520 additional hours (260 hours each)

The ITS I System Analysts will review project plan, road map and other relevant project documentation. Collaborate with technical state staff to gather and document technical system rules and provide technical system process subject matter expertise for design sessions. Identify and review technical system processes for impacted systems to satisfy requirements. Review functional/non-functional requirements and assess operational feasibility of new capabilities. Participate in project management meetings and schedule review sessions. Organize, coordinate, and facilitate meetings with state subject matter experts. Create a test plan for all impacted systems. Coordinate and execute test plans with state staff. Coordinate and execute implementation of new functionality.

ITS I – 600 additional hours

The ITS I Developers will develop the Automated Criminal History System (ACHS) sealed information output data for Automated Fingerprint Identification System (AFIS), Integra Archive and Cal-Photo.

Develop the Bureau of Criminal Information and Analysis reports, resolve defects and provide post implementation support.

ITS I – 168 additional hours

The ITS I Technical Analyst will provide writing functional requirements. Update documentation, providing analysis, conduct testing, and post implementation support for the AFIS, Automated Archive System (AAS) and CalPhoto Image Vault (CPIV) applications.

ITS I – 240 additional hours

The ITS I Developers will develop CPIV web reports, resolve defects and provide post implementation support.

<u>Technology Support Bureau:</u>

1.0 ITS I - permanent, beginning 7/1/2025

The ITS I will provide subject matter expertise for Linux operating systems and servers that support affected applications and databases to consultants through research, analysis, and attend meetings. Provide subject matter expertise for Linux operating systems and server configuration during design sessions. Provide subject matter expertise for tuning and troubleshooting Linux operating systems and servers during the development and implementation of applications.

Support and execute package installation of operating system software packages needed by the project. Review and approve technical deliverable documents as they pertain to Linux servers and operating systems. Conduct server patching and configurations that relate to operating system security and bug fixes.

C. Departmentwide and Statewide Considerations

SB 1161 creates changes to statutes that govern sealing of juvenile records that will result in more juvenile records being eligible for sealing by DOJ. DOJ will require permanent staff, consultant and additional hours from existing staff to conduct all the additional work that will be required by this bill.

D. Outcomes and Accountability

DOJ has a manual process to start implementing the sealing requirements mandated to start January 1, 2025. However, if DOJ is required to seal the records within 60-days from the date of notification by the probation department, it could pose a challenge to timely compliance with the bill's mandate. The additional resources requested under this proposal will enable DOJ to automate the manual sealing process and enact the requirements outlined as soon as funding is received. Without this funding, DOJ is unable to timely complete all the activities identified in SB 1161 and the work associated with this bill would be pushed out even further making DOJ out of compliance with the bill's mandates.

The provisions of SB 1161 overlap with part of Chapter 811, Statues of 2024 (AB 1877). However, AB 1877 has a budget contingency clause, while SB 1161 does not. DOJ will be submitting this proposal to request funding to implement the mandates of SB 1161 in the event DOJ does not receive funding for AB 1877.

E. Implementation Plan

To complete the IT enhancements that will automate the manual processes, DOJ anticipates that the IT effort will consist of two weeks of upfront planning, followed by a six-month development effort. Assuming funding becomes available July 1, 2025, the DOJ would not be able to complete the IT enhancements until January 1, 2026. Upon approval of this request, DOJ will begin the procurement and personnel process to secure the necessary staff to address the mandates identified in SB 1161.
